## 7. HANDLING AND STORAGE

OTHER TOXIC EFFECTS: BASED UPON INGESTION OF NTA IN LIFETIME FEEDING, NTA HAS BEEN SHOWN TO INDUCE TUMORS IN THE URINARY TRACTS OF RATS AND MICE. HOWEVER, ON A PRACTICAL BASIS AND ACCORDING TO GUIDELINES FOR CLASSIFICATION OF EXPERIMENTAL ANIMAL CARCINOGENS OF THE ACGIH, NTA OR TRISODIUM NITRILOTRIACETATE WOULD NOT BE CONSIDERED AN OCCUPATIONAL CARCINOGEN OF ANY PRACTICAL SIGNIFICANCE.
