SECTION 1 — CHEMICAL PRODUCT AND COMPANY IDENTIFICATION

SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Oxidizing solids (Category 2). May intensify fire; oxidizer (H272). Keep away from heat, sparks, open flames, and hot surfaces. No smoking (P210).

Hazard class: Skin and eye irritation (Category 2, 2B). Causes skin and eye irritation (H315+H320).

Hazard class: Specific target organ toxicity, single exposure; respiratory tract irritation (Category 3). May cause respiratory irritation (H335). Avoid breathing dust or fumes (P261).

SECTION 4 — FIRST AID MEASURES

Call a POISON CENTER or physician if you feel unwell (P312).

If inhaled: Remove victim to fresh air and keep at rest in a position comfortable for breathing (P304+P340).

If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do so. Continue rinsing (P305+P351+P338). **If eye irritation persists eyes:** Get medical advice or attention (P337+P313).

If on skin: Wash with plenty of water (P302+P352). If skin irritation occurs: Get medical advice or attention (P332+P313). If swallowed: Rinse mouth. Call a POISON CENTER or physician if you feel unwell.

SECTION 5 — FIRE FIGHTING MEASURES

Strong oxidizer; fire risk when in contact with combustible materials.

When heated to decomposition, may emit toxic fumes.

Nonflammable solid.

In case of fire: Use a tri-class dry chemical fire extinguisher. Take any precautions to avoid mixing with combustibles (P221+P370+P378).

SECTION 6 — ACCIDENTAL RELEASE MEASURES

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Inorganic #3. Store with amides, nitrates, nitrites and azides.

Deliquescent. Store in a cool, dry place within a Flinn Chem-SafTM bag. Keep and store away from clothing and combustible materials (P220). Take any precautions to avoid mixing with combustibles (P221).

Wear protective gloves, protective clothing, and eye protection (P280). Wash hands thoroughly after handling (P264). Use only in a hood or well-ventilated area (P271).
